## Important announcement regarding the 2023 UCT convention

As a cost-saving measure, your UCT Board of Governors has decided to make the 2023 UCT annual session a virtual event. The meeting will take place on Saturday, June 24, at 10 a.m. EST and will be conducted using a videoconference platform. There will be a dial-in option for those who don't have a computer.

We hope to accomplish as much business and fun during the session as we would during a typical convention. There will be voting for amendments, resolutions, and officers. All participants will be required to pre-register prior to the convention. More details will be provided in the coming weeks. Below are some important dates to know regarding the convention, so please read and take note:

- June 2, 2023 All UCT Standing Committee nominations must be returned to the home office. If you would like someone to represent your region, we need these nomination forms. We will be sending the nomination forms out with the regional convention facilitator packets so that during your regional convention you can make your selections and send them in.
- <u>June 12, 2023</u> All regions MUST submit their delegates list by this date.
- June 12, 2023 This is the final day to register on the UCT convention webpage.
- Week of June 12, 2023 If there are any virtual townhalls they will be held during this week.
- June 16, 2023 All committee reports to be placed on file must be submitted to the home office so that all reports can be posted online for members to review.

### **Ways to support UCT Charities**

UCT has been dedicated to helping individuals with intellectual disabilities since 1961, primarily through the UCT Scholarship Program, which over the decades has granted millions of dollars in scholarships to tens of thousands of students and teachers seeking degrees or certification in special education.

As a way to continue this important support to the scholarship program and later also to organizations helping people with special needs, the UCT Charities Trust Fund – now just UCT Charities – was established in 1997 as a 501.c.3 charitable non-profit organization for this specific purpose. The fund has grown over the years, but it needs the support of members and their local councils to continue making a difference.

UCT Charities is supported entirely through donations. Contributions may be made by individuals or groups and are recognized in an appropriate manner. Donations to UCT Charities are cumulative, allowing donors to move up in giving levels, and may be tax deductible, depending on each donor's tax status.

There are several different ways to give to UCT Charities. One of them is to purchase a **life insurance policy** that names the fund as beneficiary upon your death. This option holds the funds in an irrevocable trust and, depending upon tax status, can allow you to deduct the cost of the policy's premiums. Other options include contributing to the fund **in memory** of a deceased loved one or member or donating in honor of a special person or an event such as a birthday or anniversary.

Don't forget the 2023

reports deadlines!

As you know by now, certain local and regional council reports, submissions and financial information are due at the UCT home office each year by specified dates. It's vital that we receive the information included in the reports, so please try to get them to us in time:

Local Council New Officers Reports are due April 19, and the Regional Council New Officers are due June 12. The home office needs to know who your officers are so that we can make sure your council is receiving all the information we have to share throughout the year. If you don't send in these reports, we can't stay in touch with you – and we will consider your council inactive. Please note that we need the reports each year even if your officers DON'T change from the previous year.

The Local and Regional Council Financial Review Forms A-16 and A-21 are due by July 1. If you want your local



and/or regional council to continue to function financially without your dues being withheld, you **MUST** get these forms in to the home office on time.

Local Council 990 Tax Returns are due by August 15. If you don't submit your 990 tax returns, you are in danger of your council losing its tax-exempt status, and you don't want that to happen.
